



**RE-ADVERTISEMENT: REQUEST FOR QUOTATION – BS 20/2017**

**SUPPLY, FIT AND COMMISSION LED LIGHTS FOR THE DURBAN ICC**

**1. Background**

The Durban ICC is one of the world's leading events and meetings destinations. In order to maintain the extremely high international standards as a facility it is important to ensure the infrastructures in the various areas are correctly maintained.

**2. Purpose of the request for proposal**

The Durban ICC requires an experienced electrical contractor to supply, fit and commission LED lights outside the Durban ICC (Bus slipway between ICC and Walnut Road, along walkways from Bram Fisher Road and Stalwart Simelane Street to Durban ICC).

**3. Minimum requirements**

3.1 The service provider must <b>submit two (2) positive references</b> of providing similar services to entities having similar size and capacity as the Durban ICC.		
3.2 The service provider must submit proof of public liability insurance to a minimum value of one million rand.		
3.3 The appointed service provider will need to submit a sample of the light for approval, prior to commencing with the balance of the order.		
3.4 Service provider must have a qualified electrician performing the installation and commissioning of the lighting. Please attach a 2 page CV detailing work experience of the individuals who will be working on site.		

*Failure to acknowledge and fulfil the mandatory requirements as illustrated in the schedule above will result in the service provider being deemed non-responsive and not evaluated further.*

**4. Specifications of the Luminaire mechanical construction for the lights to be supplied:**

- The housing of the luminaire should be constructed from a pigmented resin polymer which is suitable for outdoors, has the density and characteristic to withstand impact and that is UV stabilised.
- The housing of the luminaire should have a robust construction and reinforced by means of a 316 stainless steel frame from within.
- The luminaire must allow for 2 x machined 316 stainless steel thread extensions to be inserted into the luminaire for fixing purposes. These extensions will also need to be provided.

- The LED driver should be housed within the luminaire and not exposed or visible from the outside.
- The LEDs, MPCB, heat sink and optics should also be housed within the luminaire and not left exposed to the outside elements.
- The body of the luminaire including any fastening systems should carry a minimum 5 year guaranty against rust, corrosion and or any other degradation as a result of exposure to the outdoor elements.
- The Luminaire should be designed in a manner that allows for repairs and or replacement of LED driver or LEDs for maintenance purpose.
- The luminaire should also be compatible for future technology upgrades.
- The luminaire should comply with SANS 60598 and all applicable parts thereof.

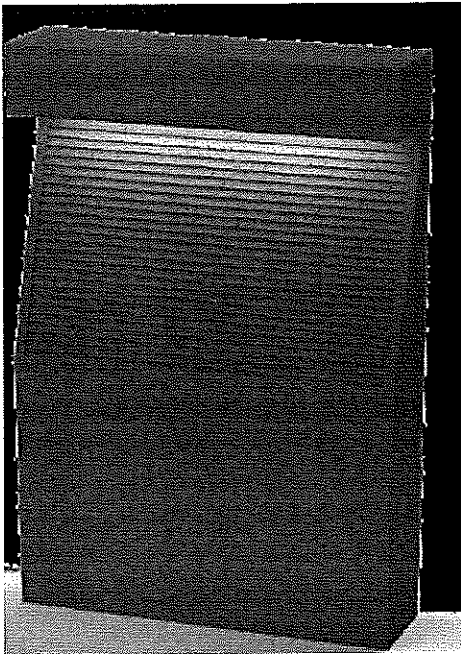
**5. Electronic performance of Luminaire for the lights to be supplied:**

- The Correlated Colour Temperature should be 3000 Kelvin, with a colour rendering index of 80.
- The luminaire should produce a minimum of 2440 flux @ 25 Degree Celsius.
- The power factor of the LED driver should be >0.96.
- The efficiency of the proposed luminaire should be at least 154lm/w @ 25 Degrees Celsius.
- The luminaire driver should have the necessary protection to overcome voltage fluctuation, overheating, short circuits, overloads, voltage spikes up to 1.0Kv and have active auto power factor correction.
- The luminaire should have additional/dual surge protection other than the protection located within the luminaire driver.
- The UGR (Unified Glare Rating) of the overall system after installation should not exceed 30.
- The LED component must be supported by a LM 80 report, with a lumen maintenance >80 @ 30000 hours calculated at Tc=55 Degree Celsius.

**6. After sales service and back-up:**

- The luminaire body and LED driver should carry a minimum 5 year warranty. The LEDs components warranty must be in accordance with LM-80 testing based on 30000 hours.
- The luminaire manufacture must be able to guarantee production of the proposed luminaire for at least 5 years, and the spares and components for a minimum of 7 years from date of purchase.
- The luminaire manufacturer should have a service centre located within KZN for servicing, repairs and the execution of warranty claims should the need arise.

**7. Proposed light exterior features should look similar to the light in the picture below:**

- All works to be carried out / material to be used/ techniques performed according to professional standards / practices / norms.
- Competent and qualified electricians must be employed to carry out the installation.
- All necessary safety precautions and preventative measures must be adhered to at all times.



**8. Preconditions**

**A written proposal/quotation will not be considered unless the service provider who submits the quotation provides the following with their proposal/quotation:**

- 8.1 Full name.
- 8.2 Identification or company or other registration number.
- 8.3 Tax reference number and VAT number, if any.
- 8.4 Valid original Tax Clearance Certificate from the South African Revenue Services which proves that the service provider's tax matters are in order.
- 8.5 Valid BBBEE Certificate.
- 8.6 MBD 4 Declaration of Interest form must be completed.
- 8.7 Statement that the company's water, electricity and rates are up to date or formal payment arrangements have been made.
- 8.8 A contactable e-mail address and/or business card must be provided together with all written proposals/quotations.
- 8.9 A completed ICC Durban (Pty) Ltd supplier application form which is available for download from the Durban ICC website ([www.icc.co.za](http://www.icc.co.za)). Alternatively, if the supplier is registered on the Durban ICC database, then the service provider need only submit their supplier number. All the mandatory documents must be included with this application.






**11. Compulsory Site Inspection**
