UPGRADE OF THE FIRE DETECTION AND COMPUTERISED MANAGEMENT SYSTEM

1. Background

The Durban ICC is one of the world's leading events and meetings destinations and currently makes use of an extremely extensive Maestro computerised fire detection and computerised management system to oversee and manage fire detection across the Facility. The current fire panels have reached end of its useful life and spares are not readily available for the current out dated model of the equipment.

2. Purpose of the Request for Quotation

The Durban ICC requires the services of a suitably experienced and qualified service provider to supply, install and commission new replacement fire panels and related equipment for the Durban ICC.

3. Mandatory scope of works and requirements

To supply, commission and install 9 X four loop addressable Fire panels and ensure that all connected detectors and devices, not limited to, interface units, line isolators and relays are fully operational on the fire panels

To supply and install 9 X 40 Zone LED modules (one each per panel to cater for the various zones on the system)		
Each Fire panel must have backup battery power in the event of mains failure.		
To upgrade the current Maestro front end system database to the latest compatible version and to a fully operational state and ensure that alarms are timeously reported on the front end system. (Please include all necessary licensing that is required)		
To carry out a full backup of the current Maestro database prior to any work being carried out.		
All equipment supplied must carry a minimum of a one year warranty and any replacement or repair work must be managed by the service provider for the duration of the warranty period.




