4. Scope of works:

4.1. Using dirt blaster or fan nozzle high pressure clean the entire support structure, the underneath of the roof and the bullnose of the entire wave structure and the bullnose on the sections of building in between the wave structure.

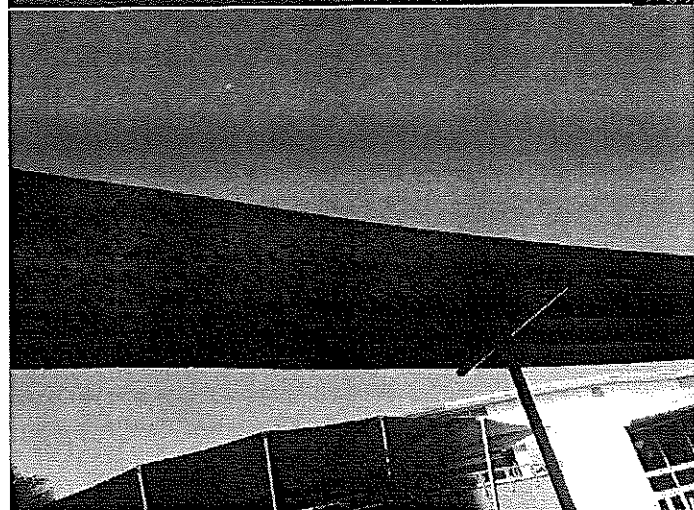
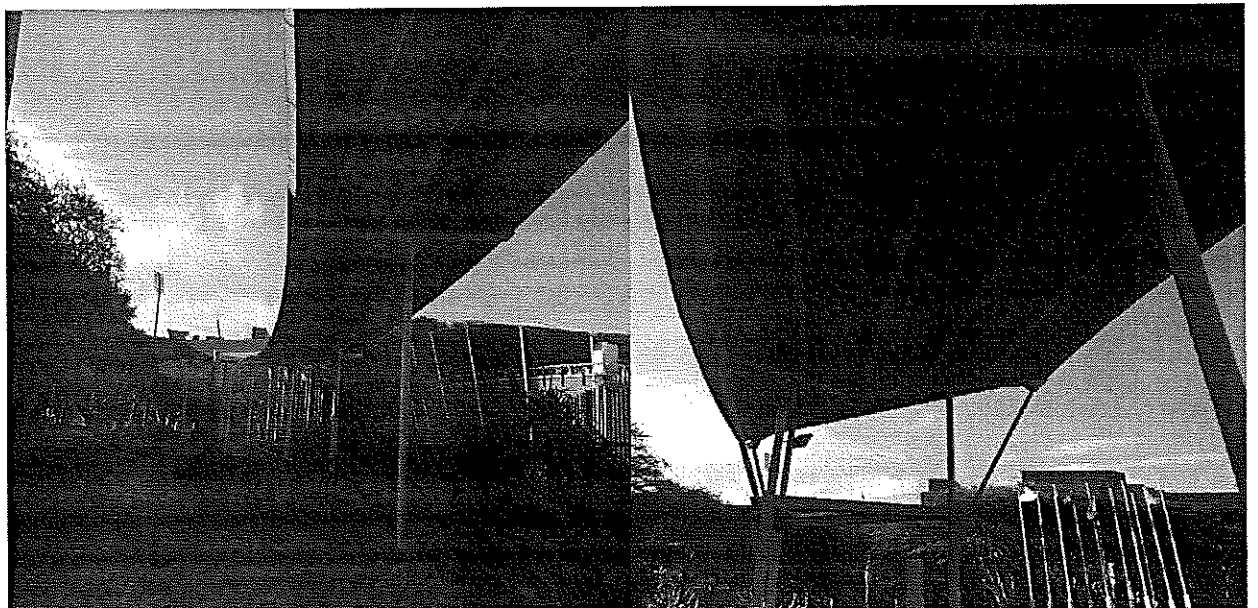
4.2. For the Support Steelwork:

- Sand down and remove all loose paint,
- Re-glaze defective putties,
- Spot prime metal with etch primer,
- Apply one coat of universal undercoat that is suitable for the final paint type.
- Finish off with Plascothane 9000 or similar approved product.


