SERVICING OF KONE LIFTS FOR A PERIOD OF 12 MONTHS

1. Background

The Durban ICC is one of the world's leading events and meetings destinations. In order to maintain the extremely high international standards as a facility it is important that we have the correct infrastructure ensuring our operations run optimally.

2. Purpose

The Durban ICC requires a registered lift servicing company to service four (4) Kone lifts currently in operation at the Centre.

All the mandatory documents must be included with this application.






