SERVICING OF THYSSENKRUPP ESCALATORS FOR A PERIOD OF 6 MONTHS

1. Background

2. Purpose

The Durban ICC requires a registered escalator servicing company to service 12 ThyssenKrupp escalators currently in operation at the Centre.

All the mandatory documents must be included with this application.



