TRAINING FOR THE DURBAN ICC BOARD OF DIRECTORS

1. Background

The Durban ICC is one of the most advanced conference facilities in the world, having been voted "Africa's Leading Meetings and Conference Centre" at the World Travel Awards 15 times.

2. Purpose of the Request for Quotation

The Durban ICC requires the services of a skilled and experienced service provider to facilitate a full day training session for approximately 15 Durban ICC board members. The full day training session is to take place before 30 June 2017 with the end objective of each Board member gaining a sound understanding, of the responsibilities and duties of the Board for a state-owned enterprise.

The training will take place at the Durban ICC premises. Meals and refreshments will be provided.

The main deliverables from the training session are based on achieving an understanding of:

- How to identify and deal with conflicts of interest;
- Delinquency and disqualification of directors;
- The powers and duties of alternate directors;
- The functioning and powers of sub-committees;
- The process of taking resolutions and the limitations thereon;
- The right of directors to be heard by stakeholders within the company; and
- Latest case studies relating to ethics and governance, to be used as practical examples.




