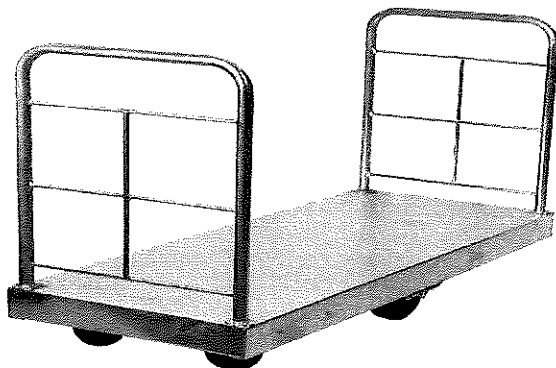

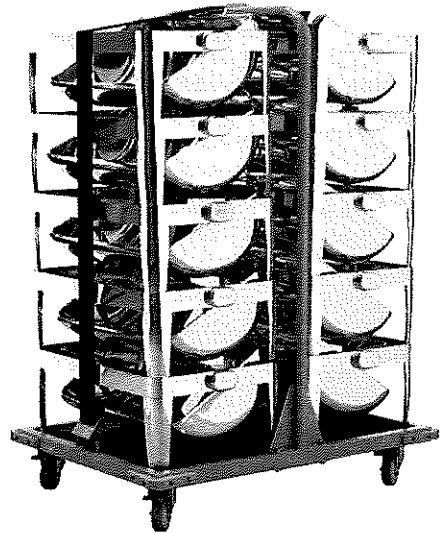
Sample picture of the Rocker trolley





