



## **ADVERTISEMENT: REQUEST FOR QUOTATION – SAE 03/2018**

### **AUDIO VISUAL CONTENT CREATION, EDITING & PROJECTION MAPPING SERVICES**

#### **1. Background**

The Durban ICC is a multi-award winning centre which has been voted Africa's leading meetings and conference centre by the world travel awards for the 15th time and has been rated amongst the world's top 15 convention centres by the international association of convention centres (AIPC).

#### **2. Purpose of the request for proposal**

The Durban ICC seeks proposals from experienced service providers for the provision of project mapping services specific to the Durban ICC's 20<sup>th</sup> Anniversary Celebratory Gala Dinner consisting of 500 pax.

#### **3. Event theme & concept**

- Over the past 20 years innovation has been the root of most sector shake-ups. It's the potent trend of controversy around us and the challenge of conventional notions.
- With that in mind, the overarching theme for the gala dinner is – "Where were you? / Changing Lives".
- It's the track record of changing lives over the past 2 decades that sets the Durban ICC apart from other Convention Centres.

#### **4. Event Brief**

- An industrial theatre production will be commissioned to celebrate the 20th anniversary of the Durban ICC. Allied to the theatrical production, the Durban ICC wishes to use cutting edge technology and current international trends to show off its facility and entertain its guests at this event.
- The successful service provider will be expected to take direction from the appointed Industrial Theatre Production Director, but also be willing to collaborate in order to create the best possible end result.

#### **5. Scope of Works**

Service providers must base their submission on the following:

- Quote for 12 minutes of projection mapping, including the development of the content and detailed technical provisions needed to facilitate this at the event.
- To provide camera crew to record various interviews and breakaway shots in and around the Durban ICC. Approximately 15 minutes of edited footage.
- To factor in editing suite time for approx. 30 min of supplied content.



- The appointed service provider will need to collaborate with the director of the industrial theatre production within which all of the above will be incorporated into, as well as the technical supplier on items such as set design, projectors, and media servers etc. imparting your specialized experience and learnings to enhance the production and make the most of the technology.

#### Additional Information

The scope of work herein with is to serve the purpose of the tender, and may change once the selected service provider has been appointed

#### **6. Negotiations and contracting**

- The Durban ICC reserves the right to enter into negotiation with one or more bidders regarding any terms and conditions.
- A supplier contract will only be deemed to be concluded when reduced to writing in a formal service level agreement signed by the designated responsible person of both parties.
- Under no circumstances will negotiations with any bidders constitute an award or promise / undertaking to award the contract.
- The successful service provider will be expected to take direction from the appointed Industrial Theatre Production Director, but also be willing to collaborate in order to create the best possible end result.

#### **7. Supplier Payments**

- The Durban ICC pays the contractor the fees set out in the final contract according to the table of deliverables. No deposit payments will be paid prior to the services rendered.

#### **8. Appointment**

The Durban ICC reserves the right to appoint one or more service providers to produce the solution or to not make an appointment if the proposals are deemed inadequate or unsuitable in terms of the requirements of the organization from the submissions received.

#### **9. Evaluation**

- The first round of the evaluation process for the proposals received will be based on the concept and how well they have been incorporated therein, demonstrating their creativity, expertise and ability to execute the required tasks at hand.
- The second round of evaluation will involve the assessment of the price and B-BBEE level.
  - A minimum quality criteria score of 70 must be obtained in order for the bidder to be deemed responsive and evaluated for price and empowerment.
  - A bidder, who does not meet the minimum quality criteria score of 70, will be deemed non-responsive and not evaluated further.
