1. Background

- Service providers must ensure size availability from XS – 5XL
- The Durban ICC reserves the right to withdraw the award from the service provider should they fail to perform their duties or fail to deliver timeously.
- The Durban ICC is not liable to make any deposit payments upfront.
- Quantities may be subject to change at the time of placing an order.
- The Durban ICC reserves the right to appoint more than one service provider for the provision of these products.

8. Preconditions

A written proposal/quotation will not be considered unless the service provider who submits the quotation provides the following with their proposal/quotation:

- 8.1 Full name
- 8.2 Identification or company or other registration number
- 8.3 Tax reference number and VAT number, if any
- 8.4 Valid original Tax clearance from South African Revenue Services which proves that the providers tax matters are in order
- 8.5 Valid BBBEE Certificate
- 8.6 MBD 4 Declaration of Interest form must be completed
- 8.7 The service provider must be registered on the CSD database and EThekweni Vendor Portal. Proof of registration needs to be submitted. Failure to be registered on these databases will adversely affect the awarding process and may result in the service provider being deemed non-responsive.






