

RE-ADVERTISEMENT: REQUEST FOR QUOTATION – BS 02/2019

SERVICE AND MAINTENANCE OF TWO (2) DIESEL GENERATORS FOR A PERIOD OF 12 MONTHS

1. Background

- 5.2 Equipment maintained and spare parts used must be according to manufacturer's specifications.
- 5.3 The appointed service provider must have or intend acquiring minimum five (5) million rand public liability cover / workmanship liability cover, prior to commencement of contract.
- 5.4 A comprehensive service record must be maintained and stamped by the diesel mechanic after each service.
- 5.5 A status report on the condition of the generators must be provided to the Durban ICC representative after each service.
- 5.6 The appointed service provider must allocate a minimum staff accomplishment, comprising of the following individuals, or similar approved:
 - One senior certified and duly experienced (>5 years) diesel mechanic
 - One junior certified and duly experienced (3 - 5 years) diesel mechanic
 - 2 x assistants
- 5.7 The appointed service provider will be held liable for any damages to the generators brought about due to:
 - poor workmanship
 - use of inferior parts
 - failure to exercise due care and competency, and
 - any other circumstances within their control and expertise






