MURAL ART PROJECT

1. Background

The Durban ICC is one of the most advanced conferencing facilities in the world, having been voted Africa’s Leading Conference Centre by World Travel Awards for 17 years. The Centre is graded 5-star by the South African Tourism Grading Council. It has also obtained certification from the International Organisation for Standardisation; in ISO 9001 (Quality Management), ISO 14001 (Environmental Management), ISO 22000 (Food Safety) and ISO 18001 (Occupational Health and Safety).

2. Purpose

The Durban ICC requires a suitably experienced visual artist to reconstruct and revitalise the existing mural on the Old Prison Wall between the Durban ICC and Walnut Road.

The project requires an artist with the required skills / talent and requisite knowledge to raise critical issues around what is known as ‘Human Rights’ in contemporary South Africa. The mural must captivate the public to engage with often-neglected critical aspects of the whole notion of ‘Human Rights’ in post-apartheid South Africa.

The artist should come up with an aesthetically and intellectually compelling work of art so that both local citizens and tourists can truly benefit from viewing it.

- The artist will be required to professionally prepare the surface of the wall by removing the existing mural and ensuring it is ready for the new work
- The commissioned artist may choose to collaborate with other up and coming visual artists at their own expense.
- The artist must ensure that the entire project meets the required standards of mural art
- The artist/s may have to avail themselves for any media interviews during the course of the project,
- The artist/s must officially hand over the mural to the Durban ICC CEO during the unveiling ceremony.






