REPAIR ROOF SHEETING FOR HALL 2 AT THE DURBAN EXHIBITION CENTRE

1. Background

The Durban ICC is one of the world’s leading events and meetings destinations. In order to maintain the extremely high international standards as a facility it is important that we have the correct infrastructure in the various areas so that our operations run optimally.

2. Purpose

The Durban ICC requires a service provider to repair the roof sheeting in Hall 2 of the Durban Exhibition Centre.

• Supply and install temporary roof ladders/safety lines to gain access to the roof and remove on completion		
• Remove damaged steel badges and flashings.		
• Install new pop-rivets on all roof sheeting joints and apply acrylic waterproofing on all pop-rivets to prevent water ingress.		
• Replace ridge flashing (450mm girth).		
• Replace barge flashing (550mm girth).		
• Replace board flute closure.		
• Waterproof all roof sheet joints to prevent water ingress.		
• Remove all waste and discard off site.		
• Paint the entire roof area once all repairs have been completed.		

Failure to acknowledge and fulfil all of the mandatory requirements and mandatory scope of works, as illustrated in the schedules above will result in the service provider being deemed non-responsive and not evaluated further.

4. Additional conditions of contract

- All works to be carried out / material to be used/ techniques performed according to professional standards / practices / norms.
- All necessary safety precautions and Health and Safety requirements must be adhered to at all times. A safety file will have to be compiled at the service providers own cost and expense and handed over to the Durban ICC before commencement of work.
- The service provider must make provision to access of hard to reach areas.
- It is the service provider's responsibility to measure the surface area of the roof to ensure that the quote matches the requirements of the areas shown during the compulsory site inspection.
- Any additional work that is not included in the scope of work will have to be quoted for and approved prior to the proceeding with work. This may be necessary if other damage on the roof is discovered during the process of repairing.
- The Durban ICC is not obligated to the appointed service provider to undertake the additional work and may test the market to ensure value for money is being achieved.
- There will be no upfront payment
- The service provider must have or intend acquiring third party liability insurance / workmanship insurance to a minimum value of two million rand, prior to contract commencement,.

5. Preconditions

A written proposal/quotation will not be considered unless the service provider who submits the quotation provides the following with their proposal/quotation:

- 5.1 Full name
- 5.2 Identification or company or other registration number
- 5.3 Tax reference number and VAT number, if any
- 5.4 Valid original Tax clearance from South African Revenue Services which proves that the providers tax matters are in order
- 5.5 Valid BBBEE Certificate
- 5.6 MBD 4 Declaration of Interest form must be completed
- 5.7 The service provider must be registered on the CSD database and EThekwini Vendor Portal. Proof of registration needs to be submitted. Failure to be registered on these databases will adversely affect the awarding process and may result in the service provider being deemed non-responsive.

- Suppliers who arrive late will not be considered.
- All suppliers will have to sign a compulsory site inspection register and will thereafter be escorted to the areas of work.
- It's advisable that the individual/s attending the compulsory site inspection have sufficient requisite experience to grasp the scope of works required for this particular project undertaking.
- Should the individual representing the company not be knowledgeable, the information discussed at the compulsory site inspection may not be transferred comprehensively to the company, which may result in the quote being misstated.
- Alterations to quotations are not allowed and no price escalations will be entertained.
- Failure to attend the compulsory site inspection will result in the service providers bid submission being deemed non-responsive.

NB. Suppliers are encouraged to do their own measurements to ensure accuracy of quotes.





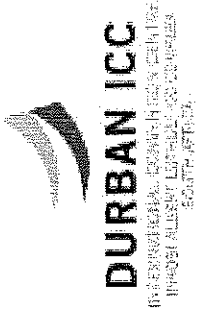
