**2. Purpose**

The Durban ICC requires a service provider to supply, install, and commission the Crestron FT – TS – 600 (or similar approved) for the Durban ICC Basement Boardroom.

**3. Mandatory scope of works**

- Supply, Install, and Commission the Crestron FT – TS – 600 (or similar approved)
- Supply 1 x POE Power supply for the Crestron FT-TS – 600
- The service provider is required to program ,test and configure the new system to work with existing Crestron control system
- Supply 1 x 10m Cat 5 or Cat 6 cable to power the Crestron FT – TS – 600
- Supply 1 x Cable retractor kit


