



RE-ADVERTISEMENT: REQUEST FOR QUOTATION – IT02/2022

SUPPLY OF INTERNET CONNECTIVITY FOR THE DURBAN ICC (INTERNAL LAN) FOR A PERIOD OF 12 MONTHS

1. Background

The Durban ICC is one of the world's leading events and meetings destinations. In order to maintain the extremely high international standards as a facility it is important that we have the correct infrastructure, thereby ensuring efficient client service.

The business currently utilizes a dedicated 15 Mbps 1:1 uncontended fibre optic link for bandwidth connectivity services to the Durban ICC internal network.

2. Purpose

The Durban ICC requires the services of an internet service provider (registered with ICASA) for the supply of internet connectivity, for a period of 12 months. With this request, we intend on upgrading to a 100 Mbps 1:1 uncontended fibre optic link (Not broadband service).

3. Conditions of contract

- 3.1. Fibre optic Internet link provision and backbone
- 3.2. Ethernet termination and hand off
- 3.3. 100 Mbps symmetrical bandwidth, 100 Mbps upload 100 Mbps download all at 1:1 contention ratio 100% international
- 3.4. Must cater for and be able to supply upgrade bandwidth up to at least 1Gbps on demand for a period of one month at a time
- 3.5. Unlimited bandwidth and no throttling or bandwidth pooling
- 3.6. Supply into management platform must be unshaped bandwidth
- 3.7. Must be redundant with a minimum of four fibre optic international backhauls
- 3.8. Access to local South African sites must not be via an international point of presence
- 3.9. MRTG ,or alike, graphing for link performance
- 3.10. SMTP mx record hosting
- 3.11. SMTP email spooling

- 3.12. 32 Usable static internet IP addresses
- 3.13. Managed router
- 3.14. Bandwidth management if required
- 3.15. 24 hour link, bandwidth monitoring and management
- 3.16. Sufficient contingency of external IP addresses must be readily available should IP addresses be blacklisted.
- 3.17. 24 hour technical and telephonic support
- 3.18. Additional 50 GB ADSL account to be supplied monthly for backup purposes
- 3.19. Including all connectivity charges i.e. uplink must be supplied to the Durban ICC Server Room

- 5.9 Statement that the company's water, electricity and rates are up to date or formal payment arrangements have been made.

- The Durban ICC reserves the right at its discretion to rescind a contract, based on the needs of the entity.
- The entity will only make a final award should the bidder be tax compliant at time of award.

- 7.1 All schedules in this document must be populated and will form part of the quotation.
- 7.2 Companies must submit a company profile and are to provide examples and references of similar work performed.
- 7.3 A contactable e-mail address and/or business card must be provided together with all written proposals/quotations.
- 7.4 The service provider must be registered on the CSD database as well as the eThekwini Municipality vendor portal database. Proof of registration on these two databases must be included together with the bid submission. Failure to register on these two databases may adversely impact on the award process.
