CLEANING OF EXTRACTOR HOODS FOR A PERIOD OF 12 MONTHS


1. Background

2. Purpose

The Durban ICC requires an experienced service provider for deep cleaning, disinfecting and servicing the extractor hood systems and their respective ducting, for a period of 12 months

- 4.9 Statement that the company's water, electricity and rates are up to date or formal payment arrangements have been made.

- It must be noted that the service provider assumes full risk when submitting bid proposals to the Durban ICC.
- The Durban ICC reserves the right at its discretion to rescind a contract, based on the needs of the entity.
- The entity will only make a final award should the bidder be tax compliant at time of award.

Proof of registration on these two databases must be included together with the bid submission. Failure to register on these two databases may adversely impact on the award process.



