4.1 Manufacture and install frameless glass trophies display cabinet (similar to one in Fig. 2) with the following specifications: <ul style="list-style-type: none"> - Height = 265cm - Width = 230cm - Depth = 50cm - The glass cabinet and shelves must be 8mm toughened glass - The base of the cabinet must be made of strong non-flexible material to allow the cabinet to be relocated to a different location should a need arise. - Front of the cabinet must have 2 sliding glass panels or 2 hinged glass doors for opening and closing. - The sliding glass panels or 2 hinged glass doors must be lockable. - The back of the panel must a full mirror panel. - All display compartments must be individually illuminated by LED lights 	R

- 5.3 Tax reference number and VAT number, if any
- 5.4 Valid compliance report, confirming compliance at time of bid submission,
- 5.5 Valid BBBEE Certificate
- 5.6 Valid SARS tax clearance pin.
- 5.7 Confirmation of registration on eThekweni Municipality's vendor portal database.
- 5.8 MBD 4 Declaration of Interest form must be completed
- 5.9 Statement that the company's water, electricity and rates are up to date or formal payment arrangements have been made.

6. Terms and Conditions

- It must be noted that the service provider assumes full risk when submitting bid proposals to the Durban ICC.
- The Durban ICC reserves the right at its discretion to rescind a contract, based on the needs of the entity.
- The entity will only make a final award should the bidder be tax compliant at time of award.






7. **Compulsory site inspection**
