

RE-ADVERTISEMENT: REQUEST FOR QUOTATION – IT 09/2022

INTERACTIVE DIGITAL MEDIA SOLUTION AND MANAGEMENT FOR A PERIOD OF 12 MONTHS

1. Background

The Durban ICC is one of the most advanced conference facilities in the world, having been voted “Africa’s Leading Meetings and Conference Centre” at the World Travel Awards 17 times.

The Durban ICC has 5 X 46-inch and 5 X 55 inch vertical digital poster information kiosks positioned throughout the Centre and requires a service provider to Design and implement a digital content solution for the screens that can be updated regularly or when required, from an online content management portal.

To supply/design, install, and commission the content services for the 10 X digital screens according to the needs and requirements of the Durban ICC as detailed in the specifications. The service provider must also quote on providing the necessary support over a 12-month period.


