1. Background

The Durban ICC requires a competent service provider to remove existing glass bricks on either side of Hall 2 entrance area and install aluminium glass windows at the Durban Exhibition Centre.

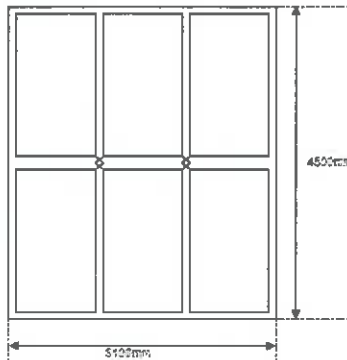

4. Specifications and scope of work

- 4.2 Strip the existing glass brick walls on either sides of the hall entrance.
- 4.3 Safely dispose of glass bricks that were removed from the wall.
- 4.4 Prepare the walls for installation of new aluminium windows.
- 4.5 Install new shopfront clear fixed glass panels.
- 4.6 Frames must be white powder coated 26B aluminium.
- 4.7 Glass must be 6.38mm Safety or Toughened Glass.
- 4.8 Wall surfaces must be plastered, cleaned and painted to match the existing walls.


8. **Compulsory Site Inspection**
