The Durban ICC requires a competent service provider for a once-off supply of concealed type flush valves for abluion facilities at the Convention Section of the Durban ICC Complex.

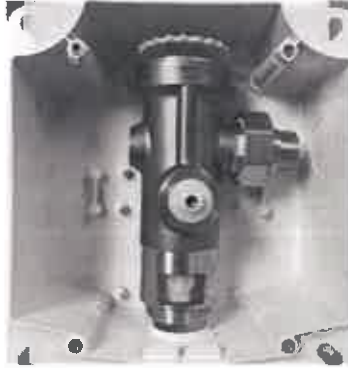
