

RE-ADVERTISEMENT: REQUEST FOR QUOTATION – CUL 16/2022

SUPPLY AND INSTALL TWO (2) DISHWASHERS

1. Background

The Durban ICC is one of the most advanced conferencing facilities in the world, having been voted Africa's Leading Conference Centre by World Travel Awards for 17 years. The Centre is graded 5-star by the South African Tourism Grading Council. It has also obtained certification from the International Organisation for Standardisation; in ISO 9001 (Quality Management), ISO 14001 (Environmental Management), ISO 22000 (Food Safety) and ISO 18001 (Occupational Health and Safety).

2. Purpose

The Durban ICC requires a service provider for the supply and install two dishwasher machines at our scullery area. This installation will be consisting of adapting the new units to the existing electrical and plumbing facilities.

3. Product Specifications

The supplied units must be suitable for a busy kitchen and capable of cleaning up 720 plates per hour with a tank capacity of 39 litres. These units must have hood clean and removable wash arms ensuring easy cleaning.

The units must meet the below:

- Three wash programs of one and half (1.5), three (3) and five (minutes) cleaning cycle.
- Liquid crystal Display LCD screen for errors code, temperature.
- The units must be user friendly.
- Wash water temperature must be 55 degree
- Dish wash rinse temperature must be 80 degree
- Noise level must be under 70dB

- Built-in chemical pumps
- Built in rinse booster pump
- Removable basket guides
- Dual washer filter system
- Temperature interlock-guarantees hot rinse
- Continuous hood clean system


