SERVICE AND MAINTENANCE OF TWELVE (12) DURBAN ICC THYSSEN-KRUPP ESCALATORS FOR A PERIOD OF 10 MONTHS

1. Background

The Durban ICC is one of the world's leading events and meetings destinations that comprises of ICC, Arena and Durban Exhibition Centre. In order to maintain the extremely high international standards, all the equipment at the facility need to be maintained at international standards in compliance with Occupational Health and Safety regulations.

2. Purpose

The Durban ICC requires a registered Lift and Escalators Servicing service provider to undertake service and maintenance of twelve (12) escalators at the Durban ICC for a period of 10 months.

• The prospective contractor must provide two (2) positive references from sites where 10 or more escalators have been serviced		
• The service provider must provide proof of public liability insurance to a minimum value of R5 Million.		
• Prospective contractors must employ qualified lift and/or escalator mechanics to work on the escalators with a minimum of 5 years requisite experience working with lifts and/or escalators. Please attach at least one 2-page CV detailing work experience of the individuals who will be on site.		
• The prospective contractor must be ISO 9001 accredited. Proof must be submitted.		

Please Note: Failure to meet all of the stipulated mandatory requirements will result in the service provider being deemed non-responsive and will not be considered for evaluation. The bidder must complete the final column above stating whether they can complete the task or not.

4. Conditions of contract

- 4.1 All work carried out on the escalators must be within specifications of the manufacturer's standards.
- 4.2 Equipment maintained and spare parts used must be according to manufacturer's specifications.
- 4.3 A comprehensive service record must be maintained and signed by the lift and/or escalator technician after each service.
- 4.4 A status report on the condition of escalators must be provided to the Durban ICC representative after each service.

4.5 The prospective contractor must have access to OEM software programmes for fault finding on the units via laptops.

4.6 The service provider must provide a fully comprehensive contract including a monthly service on each of the escalators according to the OEM maintenance schedule for each escalator (the contractor must detail a list of all exclusions from the fully comprehensive contract and these will be included in the service level agreement.

4.7 Contractor must offer 24 hour call-out service to repair defective equipment.
