

**RE-ADVERTISEMENT: REQUEST FOR QUOTATION – CUL 03 2023**

**PROVISION OF PREVENTATIVE MAINTENANCE PLAN FOR SALVIS COMBI STEAMER FOR A PERIOD OF 12 MONTHS**

**1. Background**

The Durban ICC is one of the most advanced conferencing facilities in the world, having been voted Africa’s Leading Conference Centre by World Travel Awards for 15 years. **2. Purpose of the request for quotation**

The Durban ICC requires a professional service provider for the provision of preventative maintenance plan for a period of 12 months for Salvis Combi Steamer Cucina Pro. The ovens service will consist of :

- Cleaning or replacement of Salvis Combi steam oven air filters,
- Sourcing adequate spare parts,
- Service of Salvis roll in oven trollies and castors
- Upgrade of Salvis oven software if required.


