- All packaging product to be 100% recycle preferable biodegradable or compostable.

8. Service Methodology

Coffee services

The service provider is required to outline their methodology specific to setup/layout of the catering area (front and the back of house), flow and service specific to the catering service they are presenting for.

The service provider will need to prove and ensure the highest beverage operations will co-ordinated and managed on a professional level, ensuring efficient service and optimal turnover. They will need to indicate that they have the necessary equipment and staff including the adequate refrigeration to hold stock for such large events.

Different methodologies will be considered for the different catering services. This methodology will be heavily weighted for the evaluation process to ensure there are no limited service lapses and the risk of substandard beverage offering is eliminated.
