6. Specifications

The Durban ICC has lifting equipment that we use to perform certain activities and as such we are legally bound to comply with the OHS Act 85 of 1993, the Driven Machinery regulations and any other applicable requirements or standards in respect of Lifting Equipment and/or Lifting Machinery. The regulations require that we load test and/or visually inspect the Lifting Equipment and/or Lifting Machinery by registered organisations using competent persons. The Durban ICC wants to mitigate the risk of an incident by ensuring that the lifting Equipment and/or Lifting Machinery is safe for use and fit for purpose.

Certification is needed per item (one certificate issued per item, in an electronic format via a USB) as well as spreadsheet of all items detailing a pass or fail (with relevant comments stipulated thereon for a failure).

All relevant supplier certification as a lifting equipment service provider (LME Registration with Department of Labour, LMI Registration with the Engineering Council of South Africa, Letter of Good Standing from Workman's Compensation, Public Liability Insurance, latest and valid ISO 9001 Certification (Optional). Proof of the above to be submitted or the respective RFQ will be declined.

A list of all inspected items is required stating the serial number, description, all the equipment that has passed must be on one list and the failed equipment shall appear on a separate list (with reasons for failure clearly stated). This list doesn't mean that this service provider gets to do any of the repair work nor will this mean that we promise to replace any failed equipment through this service provider.
