1. Background

The Durban International Convention Centre (Durban ICC) is currently developing a World Trade Centre (WTC) within its precinct.

As part of this development, the existing delegate registration area is being incorporated into the WTC footprint, necessitating the relocation and conversion of an existing bar area into a new registration desk and reception area.

This conversion requires selective strip-out, refurbishment, services coordination, and new finishes, in accordance with the approved interior design.

2. Legislation

This quotation will be evaluated on administrative compliance, mandatory requirements, price and preference points in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and Preferential Procurement Regulations of 2022 where 80/20 points system will be applied wherein 80 points are for price and 20 for specific goals and for this purpose the enclosed forms must be scrutinized, completed and submitted together with your detailed quotation.

3. Purpose

The purpose of this RFQ is to appoint a suitably experienced interior fit-out contractor/service provider to undertake the conversion of an existing bar area into a fully functional registration desk area.

The appointed service provider will be responsible for executing all works in accordance with the design drawings, schedules, and specifications, ensuring a high-quality, durable, and aesthetically aligned finish

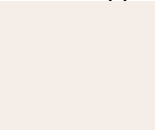
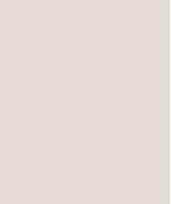

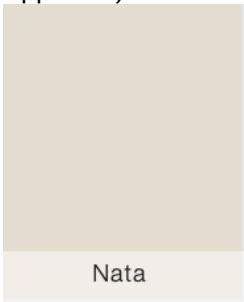
