1. Background

The Durban International Convention Centre (Durban ICC) is undertaking the development of a World Trade Centre (WTC) facility within its existing precinct.

As part of the interior refurbishment and fit-out of the facility, new aluminium-framed doors, internal windows, and a feature shopfront glazing system are required in accordance with the approved architectural design.

The works form part of a broader interior upgrade and are focused on delivering a modern, high-quality glazed interface, including the main shopfront facade within the internal ICC environment.

2. Legislation

This quotation will be evaluated on administrative compliance, mandatory requirements, price and preference points in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and Preferential Procurement Regulations of 2022 where 80/20 points system will be applied wherein 80 points are for price and 20 for specific goals and for this purpose the enclosed forms must be scrutinized, completed and submitted together with your detailed quotation.

3. Purpose

The purpose of this RFQ is to appoint an experienced service provider for the supply, fabrication, and installation of aluminium-framed doors, windows, and shopfront glazing systems.

The appointed service provider will be responsible for delivering a complete, compliant, and high-quality installation, including all materials, hardware, glazing, and finishing components in accordance with the design intent and applicable standards.
