1. **Background**

The Durban International Convention Centre (Durban ICC) is undertaking the development of a World Trade Centre (WTC) facility within its precinct to enhance its global positioning, business tourism offering, and infrastructure capabilities.

As part of this development, the existing internal spaces require refurbishment and reconfiguration to align with the approved architectural designs and functional requirements. The appointed designers have completed detailed drawings, specifications, Bills of Quantities (BOQ), and finish schedules.

This RFQ forms part of the implementation phase and covers enabling and interior works, including decommissioning and Removal of Existing Finishes, aesthetic modifications, interior fit-out, ceilings, wall treatments, and finishes.

2. **Legislation**

This quotation will be evaluated on administrative compliance, mandatory requirements, price and preference points in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and Preferential Procurement Regulations of 2022 where 80/20 points system will be applied wherein 80 points are for price and 20 for specific goals and for this purpose the enclosed forms must be scrutinized, completed and submitted together with your detailed quotation.

3. **Purpose**

The purpose of this RFQ is to appoint a qualified and experienced contractor to undertake the following combined scope of works:

- Decommissioning and Removal of existing finishes and elements
- Partitioning and wall linings
- Ceilings and associated features
- Wall cladding and decorative elements
- Painting and surface finishes

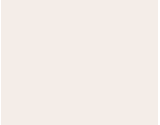

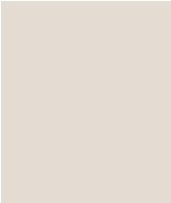
