The Durban International Convention Centre (Durban ICC) is undertaking the development of a World Trade Centre (WTC) facility within its existing precinct. As part of this development, a comprehensive furniture package is required to support the operational, functional, and aesthetic requirements of the space.

The furniture forms a key component of the overall interior design vision and includes a combination of loose furniture, custom items, décor elements, and accessories across reception areas, offices, meeting rooms, boardrooms, lounges, and shared spaces.

2. Legislation

This quotation will be evaluated on administrative compliance, mandatory requirements, price and preference points in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and Preferential Procurement Regulations of 2022 where 80/20 points system will be applied wherein 80 points are for price and 20 for specific goals and for this purpose the enclosed forms must be scrutinized, completed and submitted together with your detailed quotation.

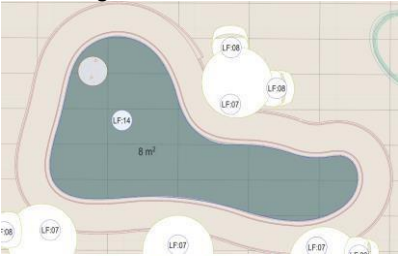

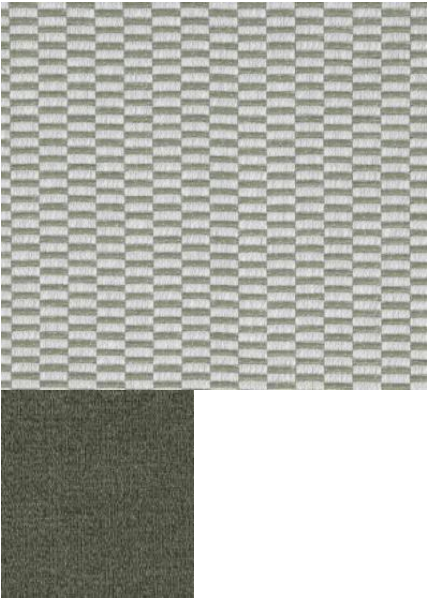
